Expand Homestead Exemptions

Concerning the expansion of property tax exemptions for certain owner-occupied primary residences (including 100% disabled veterans & Gold Star Spouses.) Increases the exemption from 50% of the first \$200,000 of actual value of the residence to 50% of an amount of actual value of the residence equal to 50% of the estimated state median home value (median home value) for the state; except that, if the median home value declines, the exemption amount continues to be calculated based on the median home value used to calculate the exemption amount for the property tax years included in the prior cycle.
